## Hepatitis C Pharmaceutical Coverage Policy

Coverage for anti-viral medications prescribed for the treatment of Hepatitis C will be covered subject to all Medical Necessity and all other provisions of the Plan and will need to conform to applicable national evidenced based guidelines as selected by the Trust "Guidelines" (i.e. current American Association For The Study of Liver Diseases (AASLD) / (IDSA) Infectious Disease Society of America) subject to the following:

- I. Compliance with current Guidelines subject to formulary restrictions and additional applicable Plan provisions and policies with the exception of the following:
  - a. Participants with Active Substance Abuse. Active Substance Abuse is defined as the use of non-prescribed injectable or other non-prescribed drugs or substances within the past 12 months which may result in reinfection. Treaters of Participants with a current history of Active Substance Abuse will be required to provide a comprehensive plan of care addressing treatment of all of the participant's current medical and behavioral health issues including plans to maximize compliance with and completion of the prescribed course of Hepatitis C treatment.
  - b. Participants with Active Alcohol Abuse. Active Alcohol Abuse is defined to be the ongoing misuse of alcohol where there is a known medical or psychiatric contraindication to ongoing use. Treaters of Participants with a current history of Active Alcohol Abuse will be required to provide a comprehensive plan of care addressing treatment of all of the participant's current medical and behavioral health issues including plans to maximize compliance with and completion of the prescribed course of Hepatitis C treatment.
  - c. Participants with evidence of known terminal disease, with life expectancy of  $\leq 12$  months.

- d. Participants with treatment being ordered by a licensed practitioner who is not a Board Certified Gastroenterologist, Hepatologist, or Infectious Disease Practitioner or other Board Certified Physician "Credentialed Specialist" experienced in the treatment of patients with Hepatitis C unless the participant has been evaluated by a Credentialed Specialist within the prior 6 months and the requested treatment has been recommended by the Credentialed Specialist.
- II. Eligibility for treatment with Hepatitis C anti-viral medications additionally requires that:
  - a. The participant must present a negative standard urine drug screen obtained within 30 days prior to initiation of therapy.
  - b. The treatment regimen prescribed is not for an indication outside of the FDA approved labeling and is prescribed as part of an FDA approved treatment regimen.
  - c. In the opinion of the prescriber, the patient is able to make appropriate decisions about treatment, comply with dosing and other instructions, and is capable of complying with appropriate physician treatment recommendations and of completing therapy. Patient non-compliance including failure to obtain required follow-up visits and required testing (i.e. HCV RNA levels during the first 8 weeks of therapy, continued alcohol or prohibited illicit substance use) may result in termination of approval for additional therapy.
